- 4. Stepfather or stepmother
- 5. Son or daughter of a brother or sister
- 6. Brother or sister of father or mother
- 7. Son-in-law, daughter-in-law, father-in-law, mother-in-law, brother-in-law, or sister-in-law
- 8. The spouse of any individual listed above
- 9. First cousin
